§1 History

This Policy was adopted at the Fall Guild Meeting 2015, edited at the Spring Guild Meeting 2016, Spring Guild Meeting 2017, Fall Guild Meeting 1 2017, Fall Guild Meeting 1 2020, Fall Guild Meeting 1 2021 and last edited at Fall Guild Meeting 1 2022.

§2 Background


During the year 2014, a lot of work was done on how the Guild would work long-term, which resulted in an operational plan that was adopted by the Fall Guild Meeting 2014. After evaluation, it was voted down at the Spring Guild Meeting 2015, and the Board in 2015 was instructed to evaluate how the Guild should instead work with Strategic Issues at the Guild. A working group was appointed, and this Policy came out as a result of the work. The work continued in 2016 when the goals were formulated.

§3 Purpose

This Policy is deliberately intended to contain very broad and abstract goals. The intention is for the Guild as a whole to work towards these long-term goals.

§4 Goals

§4:1 Community

- -sprit shall be preserved and developed.
- All members must feel welcome and included at the Guild.
- A culture where members cooperate with each other and do not oppose each other must prevail.
- All members must be treated equally.
- International students on the programs for which the Guild monitors studies must be included in the Guild's activities.
- The Guild must work to make essential information regarding the Guild's

activities available to the Guild's members.

§4:2 Education

- The Guild must work to ensure that world-class Chemistry and Biotechnology education is offered.
- The Guild must pay attention to and promote the students' physical and mental health.
- A good relationship with the Program Management, Study Guidance and other bodies at LTH must be maintained.
- Study supervision must be active and visible.
- Before and in connection with the possible relocation of courses related to the Guild of Chemical Engineering and Biotechnology, the Guild must work to maintain and improve the quality of activities that exist at the moment.

§4:3 Business Life

- A brand for the K-students in Lund, Sweden and outside Sweden's borders must be created.
- All education, both undergraduate and master's level, must be included in business-related activities.
- Opportunities to develop skills relevant to working life that are not covered by the education must be provided.

§4:4 Spare Time

- A range of events that attract all members must be offered.
- The business must be environmentally friendly and sustainable.
- There must be a low threshold for getting involved in the Guild.

§4:5 The Guild's Archives

- The Guild's archives must be kept sorted and in good condition, both physically and digitally, so that all the Guild's members

can easily access the Guild's history.

- Previous, non-digital documents and items of value in the physical archive must be digitized through photography or scanning to secure the archive.

§4:6 External Relations

- The K -Guild should be experienced as a positive presence at the Kemicentrum.
- An active collaboration must take place with the Student Union centrally and other Guilds and organizations within the Student Union.
- The Guild must maintain good relations with other student organisations, Lund University and other authorities.
- The Guild must work to organize joint events with other student organizations in Sweden and internationally that conduct study monitoring for the programs for which the Chemistry and Biotechnology Guild conducts study monitoring.

§4:7 Economy

- The Guild must work to maintain stable finances and a sound view of the economy.
